Harald Hohmann is an attorney specialised in export trade law and customs law. He advises companies in Germany, EU member states, Switzerland, the USA, Japan, China and Israel in export and customs law. He focusses on medium-sized companies in the following sectors: machine and plant construction; car producers/suppliers; electronics; defence; chemicals; medical devices; and service providers (IT, logistics and banks). His clients include six companies listed on the DAX stock market index and five on the MDAX stock market index, as well as 40 world market leaders. Harald is regarded as a "leading name in export trade and customs law" in a "highly recommended law firm for export trade and customs law" (*Juve*, 2018).

Harald has 22 years of experience as attorney. In 2002, after six years at business law firms in Frankfurt, he founded Hohmann Rechtsanwalte, in Budingen near Frankfurt, as attorney. His knowledge in export trade law is based on his comparative post-doctoral thesis of US, EU and Japanese export law, 1999, with research stays at various Universities/ministries, and on his long-time practice.

Harald is known for EU and US export law (EAR/ITAR/OFAC), EU and US embargoes (Iran and Russia), voluntary self-disclosures and operational issues in export and customs law. He is well connected to export and customs agencies of various countries. Harald is also known for his publications, among them seven books (as author or editor) in export trade law, and for his seminars, especially those held at or on behalf of the German Parliament in Berlin (he drafted the wording of § 22 para.4 AWG for legislature), the ICC in Vienna, METI in Tokyo, the Chambers of Industry and Commerce, Management Circle and SMI Defence Export.
